




Memorandum of Understanding (MOU)  
on the Academic and Scientific Cooperation  
Between  
National University of Laos (Lao P.D.R.) and  
Khon Kaen University (Thailand)




The President of National University of Laos and the President of Khon Kaen University, Thailand hereby agree to foster academic exchange and cooperation between the two Universities.

1. The two Universities will encourage the following activities in the fields of Engineering, Agriculture, Sciences, Medical Sciences, Education, Social Sciences, Foreign Language, Business Management, Economics, Architecture and related fields in particular:
  - (A) Exchange/Improvement of professors and research scholars.
  - (B) Exchange/Training of students.
  - (C) Joint research and meeting for research.
  - (D) Exchange of scientific materials, publications and information.
2. The realization of these activities is intended to be carried out after consultation and exchange of information between the two Universities.
3. The agreement is valid for a period of five years from the effective date and may be renewed before the expiration date by agreement between the two Universities.

MEMORANDUM OF UNDERSTANDING (MOU)  
ON ACADEMIC AND SCIENTIFIC COOPERATION  
BETWEEN  
SOUPHANOUVONG UNIVERSITY (LAO PDR)  
AND  
KHON KAEN UNIVERSITY (THE KINGDOM OF THAILAND)

The Director General of Souphanouvong University (Lao PDR) and the President of Khon Kaen University (The Kingdom of Thailand) hereby agree to foster academic exchange and cooperation between the two universities as follows:

1. The two universities will encourage the following activities:
  - 1) Exchange of scholars (professors, lecturers, or researchers);
  - 2) Cooperation in human resource development activities;
  - 3) Co-organising of conferences, symposia, seminars on education and research;
  - 4) Exchange of academic information and materials of mutual interest;
  - 5) Other academic, staff, non-teaching staff and student exchange that both Universities agree to.
2. Details of implementation of any particular exchange resulting from this agreement shall be negotiated between the two Universities as such cases arise on the basis of mutual benefit.
3. This agreement is subject to revision and renewal by mutual consent. Either party may terminate the agreement by written notification signed by the appropriate official of the party initiating the notice; such notification must be received by the other party at least six months prior to the effective date of termination.

MEMORANDUM OF UNDERSTANDING  
ON ACADEMIC AND SCIENTIFIC COOPERATION  
BETWEEN

CHAMPASAK UNIVERSITY (LAO P.D.R.)

AND

KHON KAEN UNIVERSITY (THAILAND)

The Rector of Champasak University (Lao PDR) and the President of Khon Kaen University (Thailand) hereby agree to foster academic exchange and cooperation between the two universities as follows:

(1) The two universities will encourage the following activities:

1. Exchange of scholars (professors, lecturers, or researchers);
2. Exchange of students (including both undergraduate and graduate students);
3. Exchange academic information and materials of mutual interest;
4. Exchange of periodical academic publications;
5. Organization of joint research programs;
6. Other academic exchanges that both Universities agree to;

(2) Responsibility of coordination of this agreement will rest the Rector of Champasak University and the President of Khon Kaen University.

(3) Details of implementation of any particular exchange resulting from this agreement shall be negotiated between the two Universities as such cases arise.

(4) This agreement is subject to revision and renewal by mutual consent after 5 years. Either party may terminate the agreement by written notification signed by the appropriate official of the party initiating the notice; the other party must receive such notification at least six months prior to the effective date of termination.
