Sub-agreement on Undergraduate Student Exchanges between College of Animal Science and Technology, Southwest University, China and Faculty of Veterinary Medicine, Khon Kaen University, Thailand

In order to promote undergraduate education cooperation and exchanges, the College of Animal Science and Technology of Southwest University (hereinafter referred to as Institution A) and the Faculty of Veterinary Medicine of Khon Kaen University (hereinafter referred to as Institution B) have reached a sub-agreement on undergraduate student exchanges between the two institutions, based on the GENERAL AGREEMENT for Cooperation and Exchange between Southwest University, China and Khon Kaen University. Thailand, signed in September 2006. The details of the agreement are described as follows:

- 1. Institution A will send 4 students majoring in veterinary medicine to Institution B for practice for a maximum of 3 months each year. Accordingly, Institution B may send 10 students majoring in veterinary medicine to Institution A to study Chinese culture and animal industry for 2 weeks each year. The tuition and accommodation fees (excluding food expenses) on the campus are waived by both institutions. Teachers are encouraged to lead the students, but the total number should be controlled as described above.
- 2. The best time for Institution A to receive the students from Institution B is April. The study period of the students from Institution A in Institution B lasts from February to April.
- 3. The students (and teachers) are responsible for their own travel costs for going to the other institution and returning to their own institution. The students (and teachers) are also responsible for their insurance payments and tourism costs.
- 4. The duration of the agreement depends upon each other's willingness. If one side decides to terminate the agreement, the agreement should expire immediately. However, the agreement cannot be terminated if the students' studies in either institution are not completed.
- 5. International common practices and laws must be followed should any disputes

occur during the implementation of the agreement.

- 6. Both institutions are eager to carry out master student education exchanges in the near future and further discussions in this regard are warranted.
- 7. One copy of the agreement is kept by either institution and it is the legitimate documentation that can be used for any legal purposes.
